Bridle Trails Park on 140th

The BTCC has worked together with the City Parks Department for years to plan, acquire land and design two parks for Bridle Trails. The first park, beautiful Bridle Trails Corner Park located at NE 24th and 134th is a small neighborhood park that is often full of activity.



The second park will be located on 140th. The City will send out requests for bids next year. Construction will start in the spring/summer of 2021. Scott VanderHyden, from the Parks Department will attend our February BTCC meeting to present additional information and answer any questions.

In the next few weeks, the City will send out a survey to ask for suggestions for the name of the park. We will post the survey on our BTCC website.

Neighborhoods continue opposition to PSE Project – by Loretta Lopez

The PSE project to build a 230KV Transmission line from Renton to Redmond is in the initial stage of appeals. PSE must obtain a permit from each of the 4 cities (Renton, Newcastle, Bellevue and Redmond). Each city must issue a decision. Each city has an appeal process which the parties must follow before the issue can be appealed through the court system.

After 6+ years of presenting the project as one continuous 18 mile project, PSE decided to divide the Bellevue portion of the project into a Southern Segment (Somerset area) and a Northern Segment (Bridle Trails area).

In the case of Bellevue, there was a hearing in March before a Hearing Examiner on the Southern Segment (Somerset area). The Hearing Examiner decided in favor of PSE. The Coalition of Eastside Neighborhoods for Sensible Energy (CENSE), a Newcastle Neighborhood group and three individuals from Bridle Trails appealed the Hearing Examiner's

decision. Now the issue will be decided by the Bellevue City Council. The public hearing before the City Council will be on October 16th at 6pm Bellevue City Hall.

The BTCC supports CENSE as it continues to oppose PSE. Warren Halvorsen, Norm Hansen, and I are the individuals from Bridle Trails who have appealed the Hearing Examiner's Decision even though the decision only addresses the Southern Segment. We are concerned that the decision on the Southern Segment will be used to justify building the Northern Segment (Bridle Trails).

How can Bridle Trails residents help? Attend the public hearing on October 16th at 6pm and listen to the arguments before the City Council. Stay informed by checking the CENSE website at cense.org. Contribute to CENSE to pay for legal and technical expertise.
